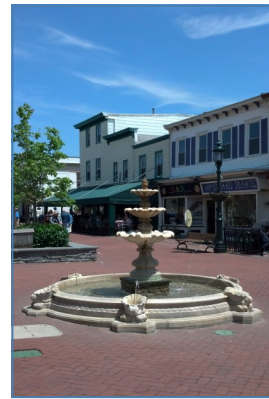
Day 1: You will journey to one of the most beautiful seashore resorts on the Atlantic Coast - **Cape May!** Your **beachfront hotel**, the only oceanfront hotel within walking distance to Washington Street Mall and the Historic District, will set the scene. Enjoy your ocean view room with a balcony (or patio) This is a non-smoking facility. (D)

Day 2: Experience the shops of the **Washington Street Mall** of Cape May on your own. Here you can browse, shop, dine, and relax. Unique shops and restaurants all within three blocks. The Washington Mall is an easy two block walk from your hotel. Enjoy a Historic **Trolley Tour of Cape May** this afternoon. (B)

Day 3: Today will be a **free day to explore Cape May on your own**, or just relax on the beach. (B)

Day 4: Board the coach to the **historic Cape May Point State Park and Lighthouse**. Depart Cape May Point and head to **Sunset Beach** and hunt for Cape May "diamonds", a natural stone of pure quartz crystal on the sandy beach. Then it's off to **a local winery** for a tour and tasting. This afternoon you have free time to walk over to the Washington Mall and Historic District to eat, browse, and shop. (B)
