Day 1: Travel to **Charlotte, NC** for an overnight.

Day 2: Visit the **Georgia Sea Turtle Center**, which encompasses sea turtle rehabilitation, research, and education programs. Stay on **Jekyll Island** for three nights. This evening enjoy a guided "beach walk" tour, discovering the maritime forests and salt marshes of Jekyll Island. (CB,D)

Day 3: Start the day with a **dolphin watch cruise** followed by a **guided tour of Jekyll Island**. Free time this afternoon/evening at **St. Simon's Pier Village**. (CB,L)

Day 4: Today, enjoy a **guided tour of Okefenokee Swamp** which highlights alligator biology, wetland ecology, and Okefenokee cultural history. Visit the **St. Mary's Submarine Museum**, dedicated to preserving the distinguished history of the Submarine Force during WWII. Free time to enjoy the **Jekyll Island Beach Village**. (CB,L)

Day 5: Visit the **Hofwyl-Broadfield Plantation**, a distinct regional, historical, agricultural, and natural treasure on the banks of the Altamaha River. Overnight in **Charlotte, NC**. (CB,L)
