**Day 1:** Travel to **Grand Rapids, MI** where you will spend two nights.

**Day 2:** Spend the day in beautiful **Holland, MI**. You will have a **guided tour of Holland**. Enjoy a visit to **Nelis' Dutch Village**, which brings the history and culture of the Dutch to life. Visit **Windmill Island Gardens**, a beautiful oasis featuring 36 acres of manicured gardens. (CB,D)

**Day 3:** Start the day with a stop at **Meijer Gardens & Sculpture Park**, a 158-acre botanical garden, art museum, and sculpture park. Enjoy a **tour and dinner at Meadowbrook Hall**, a Tudor revival style mansion by Matilda Dodge Wilson and her second husband, lumber broker Alfred G. Wilson. (CB,L,D)

**Day 4:** Enjoy a **guided Detroit Music Tour** before heading back to Pittsburgh. (CB,L)



#### **Walking Code 3:**
