**Day 1:** Cape May at Christmas time with its festively decorated streets and inns will remind you of Christmases past. On the **Holiday Lights Trolley Ride**, enjoy a cozy heated trolley while you view the spectacle of Cape May's holiday decorations. At tonight's dinner you will have a visit from one of **Cape May's Victorians** who will welcome you and regale you with a reading of a Christmas story. Your oceanfront hotel for the next two nights is a non-smoking facility. (D)

**Day 2:** This morning, enjoy a guided living history tour of the **magnificent 1879 Physick Estate, Cape May's only Victorian house museum**, decorated in authentic Victorian style for Christmas. Your guide portrays a member of the Physick family in the early 1900s and shares stories and traditions.

The tour also includes a visit to the **Carroll Gallery to see "An Old-Fashioned Christmas" exhibit**, a popular annual display featuring a huge Christmas tree, model trains, and an elaborate Dept 56 Dickens village collection.

Free time to browse, shop, dine, and relax at the lovely shaded outdoor pedestrian **Washington Street Mall of Cape May**. The Washington Mall is an easy two block walk from your hotel. Meet in the afternoon at the Washington Mall for a **Holiday Inns Tour with trolley shuttle**. These festively decorated inns, adorned in splendid Christmas finery, will remind you of bygone holidays and many Christmases of the past. (B)

**Day 3:** Following breakfast, depart for the **Historic Towne of Smithville**. Enjoy this quaint village with cobblestone streets and lovely boutiques filled with unique and beautiful gift ideas. Head for home with sugar plum memories dancing in your head. (B)
